Provides record keeping and documentation for all clinical activities. Work cooperatively and maintain professional relationships with co-workers and clients, to promote a harmonious work and team environment. Establish productive relationships with external people and organizations. Promote program and mission to clients, referral sources, and potential external supporters.
