#### Job Description

Gillis School provides educational and therapeutic services to children with MR/DD, ED/BD diagnoses and behavior disorders who cannot function in a public school setting. We are currently seeking full-time teachers and substitutes. The regular school session is August thru May and summer school session is Mid June thru July. Position responsibilities include the following: writing an Individualized Educational Plan (I.E.P.) for each student diagnosed as handicapped, developing individualized programs for each student to meet their unique educational needs and to remediate inappropriate social behavior, submitting written discharge summaries and school reports to the School Principal, submitting typed final school reports at the end of the regular and summer school term, as well as involving all treatment areas in any significant change in the child's school program.

#### QUALITIES/SKILLS:

- M.A. in Special Education preferred, B.A is required with a current Missouri certification in Behavior Disorders or Mental Retardation.
  - Experience in individualizing academic and behavioral programs to meet specific needs and deficits of the students.
